ROBBERIES WITH GUN

310 N. Schuylkill – Trail (2/3-8:47pm) (Phone/Backpack) WED ARREST

Compl states W/M 38yrs states, he was approached by a group of black males on bike, 2 produced Black Handguns and took his property. They fled and were later stopped and identified. BB guns were recovered along with the complainant's property.
