ROBBERIES WITH GUN

1503 JFK – Highway (7/31-11:22pm) (Money) FRI ARREST

Compl W/F 29yrs states, the offender threatened to shoot her then began to choke the complainant, the offender took money and fled. She was later stopped by police and identified.

ROBBERIES NO GUN
